# A. Oakland County - Romeo site

Mr. Bradshaw explained that Oakland County had submitted an application only the day before the meeting, but were requesting a waiver of the rules and consideration due to officer safety issues. The application is to move the frequency from the Addison Oaks site to the MPSCS Romeo site. Mr. Bradshaw had not had time to review the contours, and could not state if the height and power remained the same. When questioned, Ms. Coates explained that the site is about two miles east of the current site, and confirmed that coverage in the area is very poor and officers have had to use cell phones for communications. **Motion** by Berry, supported by Beckman to approve the emergency application pending satisfactory review of the contours by the Frequency Advisor. Motion carried unanimously, with Coates abstaining.
