FCC Adopted rules in November that define the accuracy and format of location information wireless carriers must provide for 9-1-1 call made from multi-story buildings. Unfortunately, the new rules ignore the advocacy of 9-1-1 experts and the APCO recommendation and fail to ensure responders will be able to locate 9-1-1 callers indoors. Instead of identifying the caller's floor level, carriers will only have to provide a raw altitude estimate. I have a copy of the press release if anyone would like to read it.

First Net National Brent Williams / John Hunt: Report submitted by Brent as follows.

This would be used largely for places that have experienced a wide-scale disaster that has taken out most all land based communications capability. And, as with all of the deployable assets, they are available upon request to any FirstNet subscriber agency, at no cost to the agency.

Since the last meeting of this group, the Dept. of Commerce has announced a new member of our Board of Directors. She is the first 911 professional to sit on our Board.

Here's a brief description:

Karima Holmes serves as the Director of the Office of Unified Communications (OUC) for the District of Columbia. The OUC is the consolidated Public Safety Answering Point (PSAP) serving the District's 700,000 residents and 20 million annual visitors. OUC manages the cities emergency 9-1-1and non-emergency and basic city service 3-1-1 call activities and maintains the public safety radio communications infrastructure for police, fire and emergency medical dispatch. Responsible for supporting the Secret Service and all presidential movements, while maintaining radio interoperability with public safety entities across the National Capital Region, the OUC handles a combined 3.1 million 9-1-1 and 3-1-1 calls and 12 million push-to-talk transmissions annually.

FirstNet's Board is made up of public safety leaders from all disciplines, telecom industry leaders, and reps from major federal Cabinet level Departments.

The FirstNet Authority is looking forward to being part of the joint APCO/NENA conference in Kalamazoo in May.

FirstNet Michigan Michael Armitage: Mike sent in the following report.

MiPSB/FirstNet Update

- Meeting this month with Verizon to hear about their public safety offerings.
- Any agency that would like to test FirstNet Coverage can do so using an app (available only on android devices) on FirstNet. The cost of the devise and service would be the

responsibility of the agency. Contact Pam if you are interested. The state is collecting this data to compare coverage maps with actual performance. FirstNet continues to be ahead of schedule (a five year plan) when it comes to build out in Michigan.

• FirstNet has two COWS available (mobile cell sites, essentially) in the state, both located in the Lower Peninsula. There is also one in Wisconsin that can serve the UP. These do take time to deploy, however if there is a large planned event or a prolonged emergency scene, they can be requested through the MPSCS NCC.

From the briefing:

Band 14

- 50% of Band 14 overlay has been completed nationwide and in Michigan and they are on target to complete their 2020 milestone in 2019.
- End of 2018 -223 sites
- To date 466 sites
- End of 2019 projected 748 new sites

FirstNet New Site Builds

- End of 2018 17 sites
- To date 24 sites
- End of 2019 projected 57 sites

State Supplemental Sites

- Some level of progress was reported on 22 of the 23 sites
- 7 sites are operational (3 in the UP, 4 in the LP)

Site Hardening

- 59 fixed generators have been added to sites
- All sites supporting critical infrastructure have been identified for priority restoration
- In-building distributed antenna systems (DAS) have been installed in 9 hospitals and trauma centers. 21 additional are planned for 2020

Adoption

- Michigan: 12k subscriptions and 250 agencies (does not include individual subscribers)
- Nationwide 600k subscriptions and 7250 agencies


APCO Old Business Chris Collom:
