## **Cybersecurity Committee**

ChatGPT has been making headlines with the fastest adoption rate ever seen with a new consumer application (Edwards, 2023). It represents a significant advance in the use of artificial intelligence to create content that can realistically appear to be the product of a human author. In the field of education, ChatGPT outputs are disrupting teaching methods (Wingard, 2023). What about cybersecurity implications?

A recent article in Forbes explores how ChatGPT may increase cybersecurity risks (Winder, 2023). The article is worth a few minutes of your time. The high level take aways are that ChatGPT could be used to: improve the quality of phishing attacks, create chatbots to enhance fake websites, and it has the potential to aid in the creation of malicious code.

#### CISA and FBI EsxiArgs Ransomware Virtual Machine Recovery Guidance

The Cybersecurity and Infrastructure Security Agency (CISA) published an ESXiArgs recovery script that victims of ESXiARgs ransomware can use to attempt to recover their files. Together with the Federal Bureau of Investigation (FBI), CISA published a Joint Cybersecurity Advisory (CSA) that provides guidance for network defenders on how to use the script as well as recommended mitigations.

According to third-party reporting, ESXiArgs actors have compromised more than 3,800 servers globally.

CISA and the FBI encourage all organizations managing VMware ESXi servers to:

- Update servers to the latest software version
- Disable the Service Location Protocol (SLP) service
- Ensure the ESXi hypervisor is not exposed to the public internet

This CSA is also available on <u>stopransomware.gov</u>, a one-stop resource for protecting and responding to ransomwarethreats, along with other advisories on the ransomware threat and no-cost resources.

#### **Health & Wellness Committee**

How many times have we heard that old proverbial saying, "You are what you eat"? Well, it turns out that it is true! As first responders, we tax our bodies every day with daily life and a high stress career. It is imperative to take better care of ourselves in order to continue to take care of those around us and in our communities. Let's throw in another old adage: "You can't pour from an empty cup". Even while resting, our bodies are working and always "on". Our bodies and brains need a constant fuel supply. An inadequate diet leads to fatigue, impaired decision making, and can slow down reaction time. It can also lead to stress and depression.

Serotonin is a neurotransmitter that helps to regulate sleep, appetite, moods, and can even help inhibit pain. Approximately 95% of the body's serotonin is produced in our gastrointestinal tract. The GI tract is lined with nerve cells and helps to digest food and guide our emotions. So, the production of serotonin is influenced by the "good bacteria" that is found in the gut. The good bacteria not only produce serotonin, but they also help to limit inflammation, help you better absorb nutrients, and activate neural pathways. (Selhub. 2022).

In order to properly fuel our bodies, we need complex carbohydrates (sweet potatoes), lean proteins (chicken), fatty acids (fish, salmon, omega 3s), olive oil, nuts and seeds (almonds and pumpkin), veggies (broccoli, spinach, tomatoes), and fruits (blueberries and apples). Some of the things to avoid are excessive caffeine, pickled foods, alcohol, processed foods, dairy and wheat. This is, of course, not a complete list, not intended to take the place of seeing your physician, and not intended to promote a diet of any kind. Simply adding a variety of these fuels to our diets can help increase our functionality on multiple levels.

One final old adage that can be used is, "Garbage in, garbage out". If you put bad fuel in your car you will likely get poor engine performance. This may not happen immediately, but over time the damage will accumulate. The same thing can happen with the fuel you use for your body. Eating a greasy cheeseburger occasionally will leave you full and ready for the next call, but a career full of gas station burritos and energy drinks will lead to trouble.

Even if you start with small changes, eating a well-balanced diet that will provide your body with the correct essential nutrients can help keep your gut healthy, serotonin levels stable and help you stay alert and healthy for years to come.




### **Commercial Corner**

2022-2023 Most Anticipated Topics


### **Commercial Corner** (continued)




We asked our participants to share their thoughts on their key takeaways from the breakfast. They had some great responses, which let us know our presentation was beneficial and educational.

## **Historical Committee**

#### The Evolution of APCO Training

The Association of Public Safety Communication Officials (APCO) has always promoted training and standards. One of the earliest standards was the establishment of the familiar "10 Codes" in 1937.

This was followed by APCO'S first publication, the APCO Standard Operating Procedure Manual, first edition, circa 1940. The official title is "Basic Operating Procedure for Police-Radiophone Stations." It was written by the State Standards Committee chaired by Ray Gronier under the guidance of Ero Erickson, then Secretary-Treasurer of the Association. This 34-page book was given to each member of the organization. Copies of the book were also available for fifteen cents; commercial members were charged twenty-five cents.

The second edition of the APCO Standard Operating Procedure Manual was funded by a grant from Law Enforcement Assistance Administration (LEAA). The manual addressed radio, teletypewriter, and radiotelegraph use. It was labeled Project Two of the APCO project series in 1967. The project was approved by APCO President Richard Quantz. J Rhett McMillan, APCO's first Executive Director oversaw the publication. It was 120 pages and sold for one dollar. More than 23,000 copies were sold by April 1971, and it was translated into French, Spanish, and Japanese.



The manual had minor changes annually when a new edition was published. In 1984 President Charles English authorized a rewrite for the twenty-first edition. The operating Procedure Committee chaired by Steve Proctor revised and updated the manual. New chapters were added including CAD and 911 Services. The cost was \$13.50.

In March of 1986 discussion started about establishing a center for basic and advanced learning on all aspects of public safety telecommunications. In March of that year the Executive Committee approved the further study of the Institute. At the 1986 Milwaukee National conference it was approved to create a subsidiary to be known as the APCO Institute.

During the 1987 Executive Board meeting it was approved to take a portion of the membership dues to establish the APCO Institute building fund. The institute would not only have a training facility, but there were also plans for field staff to take the training to individual agencies.

The resolution to establish the Institute was presented at the 1987 National Conference in Baltimore. With the resolution passing, the establishment of the Institute began in earnest. The January 1988 Bulletin lists eight courses available from the institute. This included the established 80-hour Telecommunicator Training. From this humble beginning, the Institute now offers courses in several disciplines of dispatching culminating in the Registered Public-Safety Leader (RPL) and Certified Public-Safety Executive (CPE) programs.

## **MCSC Survey Results**

In February's Member & Chapter Services Committee survey, we focused on Conference Planning. We received 22 responses from 17 Chapters. The Chapters that responded were:


We asked you, "Does your Chapter host an annual conference?" All respondents answered. Eighteen (18) said "Yes", two (2) said "No", one (1) said they hosted more than one conference, and one (1) answered with "Other". Those who answered "other" provided additional information that they hosted a workshop, typically two days in length.

In question #2, we asked, "Does your Chapter partner with other organizations for their conference?" Twenty-six (26) respondents answered, summarized below.

- Yes (14 responses)
- No (3 responses)
- Unsure (1 response)
- Other (4 responses)
  - ♦ Oregon is a combined APCO/NENA Chapter. We also partner with other groups like the SIEC/SWIC at some of our meetings.
  - We have a PSAP committee which includes members of our APCO/NENA board but also other representatives from 911 entities.
  - ♦ Once in a while, we have a joint conference with other state specific dispatch organizations within our Chapter. Our Chapter covers eight States.

Question #3 asked, "If yes, has this impacted attendance and vendor support? How so?" 19 respondents answered, with three abstaining. Responses are summarized as follows:

- Yes (9 responses)
- No (1 response)
- Unsure (8 responses)
- Other (1 response)


#### Impact Responses:

- A joint conference allows for non-competition, therefore getting a larger group of both attendees and vendors at a single event instead of spreading across two events.
- Greater attendance and more cost effective.
- I think we have increased sponsorship significantly by having an all-association conference.
- It has been a joint conference for several years, unsure if there was an increase or decrease in attendance.
- Most of the members are APCO members as well, so I am not sure if there really is a large impact. A few different members or vendors may show that wouldn't have, but for us it hasn't been a significant impact.
- NENA and APCO hold joint meetings and work in conjunction with each other in planning the symposium.
- Partnership is with the Minnesota Sheriff's Association. Sheriff's Offices oversee 80%+
  of PSAPs in the state. Sheriffs send staff due to their sponsorship of the conference.
  Vendors view sheriffs as important stakeholders in purchasing and therefore support
  the conference.
- Still basically the same industry partners that attend.
- We have been doing a joint conference for decades. I would say "yes" it likely impacts
  it, but no data to compare a standalone conference. I am not sure if we ever did a stand
  -alone conference, we are at over 35 years of joint conferences.
- We have pretty inclusive support which means more funding since our conference isn't limited to a specific organization like APCO or NENA (or something else).
- We partner with NENA and have partnered with the state 911 office in the past. We seem to get more people attending with NENA's involvement. We haven't seen a change in vendor involvement.
- We partner with the Virginia Chapter of NENA and the State Interoperability. This allows us to offer more training and information to our attendees at one conference.
   Making it less expensive on the localities.
- Wisconsin has a joint conference with both WI-NENA and WI-APCO

In question #4 we asked, "What is our average conference attendance?" Twenty-one (21) respondents answered, with one (1) skipping the question. Answers are summarized as follows:

- Less than 50 (1 response)
- 50-100 (3 responses)
- 100-250 (7 responses)
- 250-500 (8 responses)
- 500-750 (2 responses)
- 750-1000 (0 responses)
- 1000+ (0 responses)


Question #5 asked, "How is your conference funded?" Twenty-one (21) respondents answered, with one (1) skipping the question. Responses are summarized as follows:

- Registration fees / vendor booths (5 responses)
- Donations (0 responses)
- Sponsorships (0 responses)
- All the above (12 responses)
- Other (4 responses)
  - Combination of registration fees, booths, and sponsorships
  - ♦ Registration and sponsorships
  - Until 2023, registration had been free. The 2022 conference did not end up fully funded, so registration fees will appear in 2023.
  - ♦ We do not have vendor booths, just registration fees

In question #6 we asked, "How far out are your conference destinations planned/committed to?" Twenty -one (21) responded, with one not providing a response. Responses are summarized as follows:

- Same year (7 responses)
- 2-4 years (12 responses)
- 5-10 years (0 responses)
- Other (2 responses)
  - ♦ At least one year prior
  - ♦ Unsure





Question #7 asked, "Is there anything you believe your conference committee does exceptionally well that you would suggest other Chapters consider doing?" Eight (8) respondents answered. Responses are summarized as follows:

- Mentorship with chairs so we have a pool of people to continue after others have gone.
   Chapter Conference manual that spells out everything that is needed and "Lessons Learned" and finally a conference report that details all aspects of the conference.
- Annual sponsorship opportunities. Assigned committee responsibilities that does not rotate every year and participation is not limited to board members.
- Our annual awards are done at a banquet with a sit-down served meal. Awardees are given a "Make a Difference" recognition coin feel it is a step up from a certificate.
- They look for engaging, relevant keynote speakers and class tracks.
- I would suggest that other chapters consider doing a first-time attendee welcome reception prior to their welcome reception or opening. I would also suggest the incoming President lead the meeting. This way the new attendees, and in many cases new members, can feel that connection right away with the incoming President. They can also meet new people to enjoy the conference with.
- Quality time with exhibitors/networking opportunities all in the exhibit hall.
- We are still working towards standing up our conference. This is the second year under new leadership, and it seems to be growing. Overall, we are still learning.
- Meet regularly!

Thank you to those who responded to this survey. We appreciate your time and the detail you provided, as this will help the Member & Chapter Services Committee to better assist you and your Chapters.
