i. State of Michigan – Berrien Simulcast

Mr. White advised that Berrien County is changing their system to a simulcast. The application is for an existing channel, moving it to a new site. Mr. Bradshaw stated that the frequency is in the Berrien allotment and the contours are clear, but approval must be contingent upon adjacent regio approval from 14, 33 and 54. **Motion** by Berry,
