Totes can be deployed following natural disasters, line of duty deaths, unexpected deaths of co-workers and other traumatic calls. People can alert our Program Coordinators to a need through several means including a website request at http://moapco.org/involvement/totes/. Totes demonstrate to every public safety communications professional, APCO member or not, that we care about them! Since the program was approved in 2019, the team has deployed 61 Totes of Hope.



And another thing! Well, actually there are several wonderful projects and programs running here in MOAPCO - our Missouri Professional Training Partnership with the Missouri Highway Patrol is coming back strong following the pandemic. Texas Chapter Highlights

The Texas Chapter of the Association of Public-Safety Officials International (APCO) is a member driven association of public safety professionals. In addition to providing leadership, promoting professional development and fostering the development and use of technology benefiting those who access 9-1-1, Texas APCO is committed to recognizing those in the industry of public safety communications as professionals and establishing industry leading standards, training and technological advances. The members of Texas APCO serve or support that function of government which provides public safety communication services in areas of law enforcement, forestry, conservation, fire, highway maintenance, emergency rescue and medical services, emergency management, and other activities supported or endorsed by federal, state, local and tribal governments. The primary purposes of Texas APCO are to:

- Act as the authorized agency for the State of Texas Police and Local Government Frequency Coordination Program.
- Foster the development and progress of public safety communications, which includes supporting information technologies, by means of research, planning, coordination, training, and education within the State of Texas.
- Promote the rapid and accurate collection, exchange and dissemination of information relating to emergencies and other vital public safety communications among and between all levels of local, state and federal governments and those who work with them.
- Represent its members, public safety communications, and their supporting technological interests in general before regulatory and policy making bodies as may be appropriate.
- Strive to protect the citizens and their property and provide for their welfare by these and other appropriate means.

Texas is 268,597 square miles. In 2020, there were approximate 29 million residents and is the second largest U.S. state by both area (after Alaska) and population (after California). There are 29 Municipal Emergency Communications Districts, 28 Emergency Communications Districts, and 20 Regional Planning Commissions. In addition, there are approximately 1,500 members (including commercial members).

Our annual conference is held in the spring of each year usually in the month of April. During the annual conference, we present the following awards: Supervisor of the Year, Telecommunicator of the Year, Trainer of the Year, Technical Professional of the Year, and Telecommunicator Team of the Year.

Our Board of Officers is comprised of 10 dedicated members that represent different areas of Texas. The Board of Officers consists of the following: President, President-Elect, First Vice-President, Second Vice-President, Treasurer, Secretary, Immediate Past President, Executive Council, First CCAM, and Second CCAM.

We have an established Compassionate Care program called <u>"Totes of Love"</u> that focuses on showing support to Emergency Communications Centers following times of crisis. This program is use as a distraction to move past the negative feelings of helplessness that often follow traumatic events/calls.

Most of our Board of Officers have a great social media presence, in which, we have established our own Facebook page, YouTube channel, and PS Connect. We use these platforms to inform our members of events that are happening throughout the State, share stories from ECCs, and highlight our First Responders that are behind the headset. We also have established our "Membership Outreach and Development (M.O.D.) Squad to reach others to have discussions about the benefits of being a member. Using social media platforms, such as Facebook and our YouTube Channel to reach those who are not aware of our




MCSC Monthly Survey Results

In November's Member & Chapter Services Committee survey, we focused on Telecommunicator Training. We received 18 responses from 11 Chapters. The Chapters that responded were:

We asked you, "Does your state have a mandatory licensing for telecommunicators (not a certification)?" All respondents answered, with 1 (one) saying "Yes", 14 (fourteen) saying "No", 1 (one) state in the process of developing requirements, 0 (none) saying it was optional, 1 (one) who was unsure, and 1 (one) answering with "Other", with othering being that it was a certification.




In question #2, we asked, "If licensing is mandatory, what is the length of the course in hours?" 2 respondents answered, summarized below.

- 40 hours (1 response)
- 232 hours (1 response)

Question #3 asked, "Does your state have a mandatory certification for telecommunicators (not a license)?" All respondents answered. Responses are summarized as follows:

- Yes (14 responses)
- No (2 responses)
- Our state is in the process of developing requirements (0 responses)
- It is optional (0 responses)
- Unsure (1 response)
- Other (1 response)
 - Only for Law Enforcement dispatchers




In question #4 we asked, "If certification is mandatory, what is the length of the course in hours?" 15 respondents answered, with three skipping the questions. Answers are summarized as follows:

- 40 hours (6 responses)
- 80 hours (4 responses)
- 10 hours every two years (1 response)
- 16 hours for single discipline, 40 hours for multi-discipline (2 response)
- 40-hour basic telecommunicator course or approved alternative (1 response)
- 232 hours plus telephonic CPR (1 response)

Question #5 asked, "Does your state provide training?" All respondents answered. Responses are summarized as follows:

- Yes (13 responses)
- No (2 responses)
- Unsure (1 response)
- Other (2 responses)
 - ♦ Must pay to be a member of a regional training academy
 - ♦ Some but not all



In question #6 we asked, "If yes, does your state mandate their training?" 16 responded, with 2 not providing a response. Responses are summarized as follows:


- Yes (6 responses)
- No (6 responses)
- Unsure (2 responses)
- Other (2 responses)
 - ♦ They mandate and approve training
 - The curriculum is mandated; students must attend approved POST academies for the mandatory certification.

Question #7 asked, "Are mental health classes mandatory in your state?" All respondents answered. Responses are summarized as follows:

- Yes (2 responses)
- No (12 responses)
- Unsure (1 response)
- Other (3 responses)
 - ♦ It will be starting in 2023
 - Most agencies make it mandatory but there is nothing in statute
 - **O** The state is currently revising the curriculum and it will include mental health content

In question #8 we asked, "Is continuing education required after the first year?" All responded. Responses are summarized as follows:

- Yes (14 responses)
- No (4 responses)




Question #9 asked, "If yes, how many hours per year?" 14 answered, with four not responding. Responses are summarized as follows:

- 1-5 (1 response)
- 5-10 (1 response)
- 10-15 (2 responses)
- 15-20 (2 responses)
- 20+ (4 responses)
- Other (4 responses)
 - 20 every two years
 - 40 every two years
 - 24 every three years

In question #10 we asked, "Does your Chapter offer scholarships for required training courses?" All respondents answered, summarized as follows:
